PART C: Measures implemented or to be taken to improve gender-balanced representation on the Company's Board of Directors.

The Board of Directors acknowledges the importance of its composition—not only for compliance with existing legal requirements, but also for shaping a strong corporate culture that effectively promotes diversity and equal opportunities. Furthermore, it closely monitors developments in the legal and regulatory framework, particularly regarding the increasing requirements for gender-balanced representation, ensuring the adoption of best practices in corporate governance.

In this context, the Company's BoD conducts an annual detailed assessment of the collective and individual suitability of its members, focusing on effectiveness, collaboration, professional ethics, and the members' contribution to the realization of the Company's vision, as well as identifying areas for improvement in terms of gender-balanced representation and diversity. In all respects, the Company ensures, at every level of operation and management, the



exclusion of any form of unfair discrimination (including gender-based discrimination), by implementing internal procedures and policies that support meritocracy and the empowerment of underrepresented groups.

With regard to adequate gender representation, the Company places significant emphasis on the amendments introduced to Law 4706/2020 pursuant to Article 5 of Law 5178/2025, effective as of 30/06/2026.

All required actions, as well as revisions to the Company's existing policies and procedures, will be implemented within the prescribed timeframe, with a focus on continuously improving gender balance and enhancing the collective suitability of the Board of Directors.
